Description

The Lead Teacher is responsible for developing a cohesive teaching team, coordinating the curriculum, and managing the day-to-day operational activities of the classroom. Teachers must understand children's cognitive, social, emotional and physical developmental needs in order to ensure a safe and stimulating classroom environment where children are actively engaged and encouraged to succeed. The Lead Teacher for Pre-K Counts (PKC) has record-keeping and reporting responsibilities as required by the PKC program.

Responsibilities

- Uphold the mission, vision, and values of CORA Services, which includes valuing all individuals, supporting the individual's potential for growth, and enhancing a programmatic service system approach.
- Coordinate and implement educational lesson plans based on developmentally appropriate practices and early learning standards, in conjunction with the assigned OCDEL-approved curriculum.
- Plan individual and group activities to actively engage children and encourage cognitive, social, emotional, and physical development.
- Develop schedules and routines to ensure adequate physical activity, rest, and playtime.
- Ensure a safe and healthy learning environment including maintaining appropriate hygiene and cleanliness standards and safety and security of children.
- Guide Assistant Teacher(s) and classroom volunteers to ensure they are following planned activities and standards. Encourage teaching team success through modeling and coaching.
- Monitor growth and development of children based on established learning objectives using age-appropriate assessment tools.
- In consultation with Center Director, make appropriate referrals for children needing additional services.
- Establish positive relationships with parents and maintain frequent communication about student's growth and progress through informal discussions, progress reports, and parent-teacher conferences.
- Ensure all center policies and state regulations are met.
