CLASSROOM MANAGEMENT

- Applied the use of an ABA program to promote positive reinforcement and positive behaviors within the classroom for special education students.
- Differentiated instruction to meet the needs of dual language learners and students with emotional and/or learning disabilities.
- Assisted students with testing, including modifications for PSSA exams, oral testing for content knowledge, assistance with dyslexic students.
- Referred students to school counselors and other personnel as necessary and provided assistance to students before, during and after class as needed.
- Reduced absenteeism and classroom behavioral problems by 15% through student-led committees on classroom behavioral expectations.
- Implement activities that support positive mental health and increase student social skills.
