Provides individual, group, and family therapy to clients on the autism spectrum, as well as, to clients with other mental health concerns. Writes treatment plans, completes progress notes, and all appropriate documentation for each session.

Team Leader, February 2017-October 2018. The Center for Autism, Philadelphia, PA. Responsible for assessing, creating, and implementing treatment plans and intervention strategies for clients on the Autism Spectrum. Supervise, mentor, and model therapeutic techniques for members of a therapeutic team. Responsible for completing and auditing progress notes to facilitate billing process. Create and facilitate structured weekly schedules for clients. Maintain physical environment of the program room in order to best facilitate clinical interventions and client safety. Confirmed completion and accuracy of clinical assessments. Participate, collaborate, and plan in Team Meetings. Strategize behavioral interventions and quantify behaviors to assess effectiveness of interventions and progress. Supervise team members weekly.
