I strongly recommend Logan Leeds-Ezell for your counseling position. As Logan's internship site supervisor at Philadelphia Performing Arts: A String Theory Charter School (PPACS), I've had the pleasure of supervising her for the 2019-2020 School Year. At PPACS, she worked with 7th & 8th graders (approximately 400 students). Logan is professional, dedicated, supportive and has a very calm demeanor that students gravitate towards.

Logan came to PPACS for 3 full days during the 2019-2020 School Year. During this time she attended and participated in all related meetings (MTSS, Child Study, Attendance, Counseling Team, Professional Development, etc), observed individual and group counseling sessions and transitioned to running her own groups and check-ins with students. Logan quickly became a staff member that students wanted to talk to and she began to have her own caseload of students. In the late fall, she proposed a Self-Compassion Group with some of our students in mind. This 4-week counseling group addressed issues related to self-esteem and self-worth. The basis of the group was to provide a space for students to reflect on their personal notions of self-worth, share stories, and learn about the value of self-compassion. The goals of the group were to increase the student members' self-esteem and feelings of self-worth, build a community amongst group members, and foster self-compassion. Logan's group was not only successful, but it sparked more students to request to attend this group and together, we formed a few more during the school year!

In addition, I've witnessed Logan use many counseling strategies effectively with students, such as listening, validating, displaying empathy, open questioning and helping students reflect on their decisions/behaviors. Logan is a team player and thinks outside the box with ideas that are new and innovative. Logan helped put together a very successful Career Day for our middle school students with over 20 professionals and over 100 sessions! In addition, she helped introduce our Act 339 activities with teachers and students through our seminar (advisory) class and assisted in monitoring their compliance for the state. Logan also took the lead on curriculum for our seminar classes and created a 4-week set of lessons for 5th - 8th graders to do electronically through the school closure for the pandemic.

I am very grateful for her support this year and will miss her presence in our school. I highly recommend Logan to your school, I am confident she will be a huge asset to your team. Please feel free to contact me at any time if you would like more information.


